Clients who complete our Ad Package are able to put up to 10 photos on our website as well as several other web sites, and one photo on Realtor.com. For the MLS only listings (option 3), just 1 photo is included. You can submit additional photos up to a total of 10, the 9 additional photos are \$10 each. If you have already submitted photos to us for an ad in our magazine & website you do not have to submit the photos again for your MLS listing.

Combination lockboxes are available for \$40, includes shipping.

Realtor.com Showcase listings available for \$100 for up to 10 photos.

If you require yard signs or open house signs please call us for prices.

Your MLS listing will be processed within 24 hours of the start date you put on page one of the listing contract. At that time you will be in MLS, and your listing and photos will be available to all agents. **Please note, though...** It can take several more days for your listing to appear on realtor.com, CTReal.com, etc. It may appear first without a photo. Be patient. Within a week your home and photo will appear on those sites.

Don't hesitate to call us with questions or to make changes to your listing. **When you accept an offer from a buyer you must let us know right away.** We are required to mark it appropriately within 24 hrs of you accepting an offer or we get fined by MLS. Unfortunately if this happens, we will have to pass the fine along to you. So please help us by keeping in touch with us regarding the status of your listing. (Don't worry, if the agreement falls apart we can reactivate your listing right away at no cost to you.)
